I understand that the information I get access to is copyright protected, and that I am only allowed to share it with other people in accordance with this affidavit, which functions as a license agreement between me and K9joy®.

I declare that I shall not, under any circumstances, share the information I receive in response to this affidavit with others, including (but not limited to): my peers or superiors, government representatives, and/or employees, unless explicitly ordered to by a court of law. I understand and agree to this statement under penalty of perjury, fraud and other charges. I am fully aware that any breach of this covenant and of any of the terms outlined in this affidavit can and will be used against me in a court of law. I also agree that, in case of such a breach, I will be responsible for all incurred damages on the part of K9joy® and its affiliates and associates, including (but not limited to) their legal fees, employee time, subcontracted work, lost business, etc. that might arise from such a breach. In case I should be in breach of any of the terms below, I acknowledge owing K9joy® a non-disputable and non-refundable penalty of 10,000.00 (ten thousand) Canadian dollars in addition to any of the above mentioned damages.



I understand and respect that my access to this information is subject to the following terms:

1. I am not permitted to alter any articles. "Altering" shall include "omitting anything", such as headline, subtitle, or the bio at the end.
2. I am not permitted to copy any coding of any web pages, except the URLs, as outlined below.
3. I am not permitted to pass on to others the URL or the pass code for the overview page I get access to through this license.
4. I may print out the PDF version of any article, copy it, and distribute it to an unlimited number of people, on a strictly non-commercial basis.
5. I may attach the PDF-version of any article to an e-mail and forward it to an unlimited number of recipients, on a strictly non-commercial basis.
6. I may post the URL for any article on any web site, on-line forum, blog, newsletter, or similar, and I may add to the URL my own affiliate information in accordance with K9joy's affiliate program.
7. I may use the TEXT version of any one article in my on-line newsletter, as long as I publish only one article per issue, and I may pass on that permission to other on-line newsletter editors, on article at a time.
8. I may distribute a maximum of five articles at a time, at the same event, on the same day, on the same web site, in the same blog, in the same medium, or in the same posting in an on-line forum; this goes for distribution of printed copies, URL references, e-mail attachments, and any other means of distribution. I am *not* allowed to facilitate the posting or publication of more than five URLs to these articles in any one public place, physically or on-line; this includes any articles posted at that location earlier or by others.
9. I may post <http://k9joy.com/dogarticles/index.php> anywhere on-line, regardless the above, and I may include my affiliate information in the URL.
10. I am not allowed to copy any web pages in HTML code, or in any other way distribute those pages. Only PDF files may be printed. And only TEXT files may be included in on-line newsletters. Both PDF files and TEXT files may be attached to e-mails. Distribution of the web pages themselves is exclusively allowed through passing on the URLs for them.
11. I am not under any circumstances allowed to charge money for these articles or in any other way make them part of a deal that has commercial nature, without prior written permission from K9joy. Such permission will normally be granted when a fair win-win proposal is submitted along with the request for such permission. This particularly includes fund raising events.
12. The limit of five articles, as mentioned in several points above, can likewise be made subject to an exemption if a written proposal/application therefor is submitted to K9joy.
13. "Commercial basis" as referred to above shall mean any kind of trade of the articles that is not a clear donation to the receiver. A merchant handing out copies of the articles as "freebies" to customers in his/her business shall not be considered "commercial basis", as far as the hand-out of the article copies goes, regardless of the hand-out taking place in a commercial setting, as long as the commerce conducted in that situation is not influenced or altered by the hand-out.



I understand that K9joy® will submit to me further instructions for accessing the web page with the live links and URLs for all the articles published by Mogens Eliassen through K9joy® when you approve of this affidavit. I understand that if the e-mail address I gave you above is illegible or invalid, I will hear nothing from you, and my payment then becomes non-refundable.

I declare all of the above information to be true, and I commit to the covenants given above, under respect for the law in my country, as well as the law of the Province of British Columbia, Canada, where any disputes over this ultimately shall be resolved:
